AB 878 Passes the Assembly! Next Stop: WI Senate

AB 878 The Family Health Benefits Act, a Bill to promote the development of Health Benefits Counseling services statewide, was on the floor of the WI Assembly on Tuesday, April 20 at 10:55pm.

The Bill Passed 50-48!
