#### **HEALTH REFORM BECOMES LAW!!**

#### ...AND THAT'S NO FOOLIN'!

After nearly a century of contentious debate, health care reform is finally the law of our land. The need for health insurance reform crossed many lines of income, race, gender, and political parties. The lack of reform had stymied Americans as they stumbled through the maze of private coverage and public programs that should help people, but left over 48 million uninsured.



The Patient Protection and Affordable Care Act, which includes health insurance exchanges, changes to private insurance regulation, a boost to local Medicaid programs and more, was signed into law on March 23 by President Obama. Meanwhile, a reconciliation bill with a manager's amendment went from the House to the Senate, back to the House, then to the President, who signed the bill into law in on Tuesday, March 30.

The vote on Reconciliation came after Senate Democrats defeated more than 40 Republican amendments intended to slow or stop the legislation. The final House vote was  $\underline{220 \text{ to } 207}$ , and the Senate vote was  $\underline{56 \text{ to } 43}$ , with the Republicans unanimously opposed in both chambers.

According to David Herszenhorn and Robert Pear of the <a href="New York Times">New York Times</a>, "the reconciliation bill makes numerous revisions to many of the central provisions in the measure adopted by the Senate on Dec. 24, including changes in the levels of subsidies that will help moderate-income Americans afford private insurance, as well as changes to the increase in the <a href="Medicare">Medicare</a> payroll tax that will take effect in 2013 and help pay for the legislation."

### Coming Soon: Immigrant **Health Coverage Workshops**

March 30: Insurers to Comply with Rules on Children

- Assists states in providing health insurance consumer information: Provides aid to states in establishing offices of health insurance consumer assistance in order to help individuals with the filing of complaints and appeals. Effective beginning in FY 2010.
- Prohibits plans from imposing lifetime limits on coverage. Effective 6 months after enactment.
- Begins to phase out the Medicare Part D "donut hole": A rebate of \$250 is available to Medicare benefiticiaries who reach the donut hole in 2010. Beginning in 2014, this prohibition would apply to all persons. Effective calendar year 2010. (Beginning in 2011, a 50% discount on brand name drugs will exist in the donut hole. The donut hole will be closed by 2020.)

### Family Health Benefits Bill-Status Report!

Health Reform is the law of the land and people across the country are preparing for changes. Bobby Peterson of ABC for Health comments, "Wisconsin is in better shape than most states, but we can do better. The health reform bill's new rules and requirements may be overwhelming for consumers. We need to help people connect to new and emerging public and private health insurance programs. The new changes will be confusing and we must prioritize actions that help people obtain and maintain health care coverage."

In preparation for a changing health care landscape, ABC for Health partnered with the Department of Health Services and the Office of The Commissioner of Insurance as well as lead sponsors Senator Miller and Representative Donna Seidel to develop the "Family Health Benefits Bill" (AB 878/ SB 633) to lay the foundation to support a statewide network of Health Benefits Counselors in Wisconsin.

**Next Steps:** The Family Health Benefits Bill went to Executive Session in the Senate Committe on Health, Health Insurance on March 30 for a vote-ending in a tie. The Bill went to the Assembly Committee on Health and Healthcare Reform on March 31 for a vote and passed 8-4. The Bill will move to the Joint Finance Committee and to the full Assembly for a vote during the April floor session.

Ops Memo 10-30: Wisconsin Works (W-2) Policy Updates on Cooperation with Child Support and Child Support Assignment and Distribution (Released March 31, 2010)

**New Policy:** This Memo focuses on improvements to: Communication and collaboration between the W-2 Agency and CSA; and updated information by W-2 Agencies to W-2 applicants/participants about assignment ing and distribution of Child Support payments, to improve W-2 applicants'/participants' choices regarding the financial well-being of their families.

Ops Memo 10-29: W-2 Screening and Assessment (Released March 30, 2010)

**New Policy:** The memo includes a new release of Chapter 5 of the W-2 Manual, now titled *Screening and Assessment*. It also provides an overview of the screening and assessment policies that have changed in Chapter 5 and includes the release of two new W-2 medical assessment forms.

Ops Memo 10-28: Disregarding Making Work Pay (Released March 30, 2010)

#### State or Federal Inmates

New information from the Bureau of Justice Statistics on the number of adult prisoners under state jurisdiction and the incarceration rate per 100,000 population has been added for all states and the nation for 2008.

#### **Union Workers**

The latest information from the Bureau of Labor Statistics (BLS) on the number of workers represented by unions has been updated and is available for all states and the nation for 2009.

#### Food Stamp Program

The latest data from the United States Department of Agriculture's (USDA) Food and Nutrition Service on monthly food stamp enrollment are available for all states and the nation for December 2009. Also available are data on average monthly participation in the food stamp program, average monthly food stamp benefits, and total food stamp program benefits for fiscal year (FY) 2009.

#### <u>Unemployment</u>

The most recent unemployment rate data have been added from the BLS for all states and the nation for February 2010.

#### State Fiscal Distress

Measures of aggregate state rankings in foreclosures, unemployment, and food stamp participation have been updated with the latest data from the BLS and the USDA.

#### **Health Status**

#### **Newborn Screening**

The most recent information on states that require newborn <u>hearing</u> screening and newborn <u>cystic fibrosis</u> screening are now available from the National Newborn Screening and Genetics Resource Center for 2010.

#### Childhood Immunization

The latest information from the Centers for Disease Control and Prevention (CDC) on the percent of children ages 19-35 months who are immunized has been added for all states and the nation for 2008.

#### Child Oral Health

New state-by-state data from the Data Resource Center for Child and Adolescent Health (DRC) on the percent of children with oral health problems have been added for 2007. Child and Teen Death Rates **New Policy:** The purpose of this memo is to instruct local agencies to exclude tax refunds from the Making Work Pay tax credit when counting income for the Wisconsin Shares eligibility or co-payment purposes, Wisconsin Works, Emergency Assistance, and Job Access Loans.

Ops Memo 10-25: Preprinted Mail-In Renewal Forms and Process (Released March 30, 2010)

New Policy: To help make it easier for children to retain their health care coverage, the State has made preprinted renewal forms available for children receiving BadgerCare Plus or Medicaid (This preprinted renewal form can also be used for EBD Medicaid, Family Planning Waiver, and Caretaker Supplement mail in renewals.) Starting April 1, 2010, the paper renewal forms can be used to complete the annual review required for each program. Individuals can also complete their review in person, over the phone, or using the new online renewal process (access.wisconsin.gov). When it is time for the annual review, families will receive the renwal packet in the mail from their case worker. This packet will include: a Printed Case Summar; a Renewal Cover Letter (dhs.wi.gov/em/forms/imforms.htm); and a Renewal Signature Page (dhs.wi.gov/em/fforms/imforms.htm). Please note that individuals who also have FoodShare benefits can renew their benefits through the paper renewal form, but must also complete their FS interview.

Ops Memo 10-24: Earned Income, Homestead, and Other Tax Related Income (Released March 24, 2010)

**New Policy:** This Memo provides Tax Year 2009 information and reminds Wisconsin Works (W-2) Agencies and others of the importance of notifying program participants of the financial advantages of state and federal Earned Income Tax Credits (EITC), the State Homestead Credit (HC), the federal Child Tax Credit (CTC) and other available tax credits for low-income families. This memo also provides information on where low-income, non-English speaking and elderly families can obtain free tax return preparation assistance in Wisconsin.

Ops Memo 10-22: Wisconsin Works (W-2) Work Program Auto Disenrollment (published on March 17--not released until April 1, 2010).

**New Policy:** Several changes over the last couple of years (Ops Memo's 09-18 and 06-27) have been made to help ensure that W-2 cases are closed properly. This final phase will end activities and automatically disenroll W-2 participants who have no W-2 placement and no W-2 eligibility. This will help ensure that performance standards are not erroneously counting individuals who are not actually receiving W-2 services.

Ops Memo 10-21: Disregarding Income for Temporary Census Employment for FoodShare (Released March 22, 2010) Effective March 1, 2010

**New Policy:** The State announced a new policy change for individuals participating in or interested in participating in the Wisconsin FoodShare program who are temporarily employed by the US Census Bureau. Income for both full-time and part-time census takers and enumerators for the 2010 Census WILL NOT be counted as earned income in determining FoodShare benefits **as long as** the employment is temporary. (This income has always been disregarded for health care programs.) Please note that income from permanent employment with the US Census Bureau WILL be counted as income for FoodShare and Medicaid.

Ops Memo: 10-17: BadgerCare Plus Certification for Court Ordered Kinship

Updated data from the Annie E. Casey Foundation on the death rates of children ages 1-14 and teenagers ages 15-19 are available for 2006 for all states and the nation.

<u>Violent Crime Offenses and Occupational</u> Fatalities

Updated data from the US Department of Justice on the rate of <u>violent crime</u> offenses per 100,000 inhabitants are now available for 2008. Also added for 2008 are the latest state-level data from the BLS on <u>occupational fatalities</u>. Disability Prevalence

The most recent information based on Cornell University's analysis of the American Community Survey (ACS) on the percentage of adults with disabilities is available for all states and the nation for 2008.

#### Cancer

The latest data from the CDC and the National Cancer Institute (NCI) on the overall cancer incidence rate per 100,000 population, the cancer incidence rate by gender, and the cancer incidence rate by race/ethnicity have been added for all states and the nation for 2006. Updated information from the Agency for Healthcare Quality and Research (AHRQ) on the rate of deaths due to colorectal cancer per 100,000 population is available for 2005.

Care Children

New Policy: If a child is in a court ordered kinship care placement, her Medicaid/BadgerCare Plus eligibility will now be determined by the Child Welfare Agency, not the County Economic Support Worker. (Children in VOLUNTARY kinship care placement will continue to have their eligibility determined by the County ES worker.) Families affected by this procedure change can expect to get a negative notice in the mail. Pay close attention to that notice, as that letter should simply terminate the county's handling of the case, and should NOT terminate the child's benefits. There should be no gap in coverage.

## CASE TIP: Federal Poverty Guidelines Stay at 2009 Levels

Congress has taken action to keep the <u>2009 poverty guidelines</u> in effect until at least March 31, 2010.

It took an act of Congress to keep the 2009 poverty guidelines in effect well into 2010. Why? The Consumer Price Index annual average for 2009 went down. Without action, Health and Human Services would have had to issue 2010 poverty guidelines that were **lower** than the 2009 poverty guidelines. The US <u>Department of Health and Human Services Web Site</u> provides the following detail on the actions Congress has taken on this matter:

1. On December 19, 2009, Congress enacted and the President signed the <u>Department of Defense Appropriations Act, 2010</u>, which included a provision to **freeze** the Department of Health and Human Services poverty guidelines at 2009 levels in order to prevent a reduction in eligibility for programs including Medicaid, Supplemental Nutrition Assistance Program (SNAP), and child nutrition, through March 1, 2010. A <u>Federal Register</u> notice about this initial extension of the 2009 poverty guidelines was published on January 22, 2010.

2. On March 2, 2010, Congress enacted and the President signed the <u>Temporary Extension Act of 2010</u>, which included a provision that replaced "March 1, 2010" with "March 31, 2010".
