Operations Memos

Below, find Wisconsin's Department of Health Services (DHS) Operations Memos (Ops Memos) or information updates, with brief summaries and/or rationales drawn from the information provided by DHS. Any "Opinions" highlighted below are interpretations of HealthWatch Wisconsin staff and Update editors. Follow the links to view the actual memos:

Operations Memo 10-51: FoodShare Eligibility for EBD

Households (Released July 1) New Policy: Income: Effective immediately, households that include an elderly or disabled member with gross household income over 200% of the FPL must be tested for FoodShare using the regular SNAP rules. Under the regular SNAP rules, these households have no gross income limit, but must have net income that does not exceed 100% FPL. Assets: Households tested under the regular SNAP rules must have countable assets at or below \$3000. The FoodShare Handbook Chapter 4.4 has been updated with the current policy regarding when to count or exempt assets.

Operations Memo 10-50: CARES Screen for WPBD Updates (Released July 1) New Policy: As described in DFES ADMINISTRATOR'S MEMO 10-05, the Wisconsin Department of Health Services and HealthWatch Wisconsin will issue a call for proposals to invite coalitions to compete for funding. We will prioritize coalition development for low-enrollment, underperforming or health disparity locations across Wisconsin. In fact, HealthWatch Wisconsin will prioritize coalition development where local health departments take a leading role. After funding, HealthWatch Wisconsin will be looking for areas that can DEVELOP and SUSTAIN a coalition, after the start-up assistance is complete.

Federal High Risk Pool Accepts Applications July 15

Wisconsin is expected to begin taking applications for the Federal Health Insurance Risk Sharing Plan (Federal HIRSP) on July 15, 2010 for an August 1 effective date. Administered through the existing Wisconsin HIRSP authority, the Federal HIRSP plan will have different eligibility and application requirements from what we know as the existing State HIRSP plan. To qualify for the Federal Pool, a person must:

- 1. Be a citizen or national of the United States, or be lawfully present; and
- 2. Have a preexisting medical condition; and
- 3. Been uninsured for at least 6 months before applying for the HIRSP Federal Plan.

Keep your eye on the <u>HIRSP website</u> for new details as they become available. Be sure to visit the <u>Frequently Asked Questions Tab</u> for the interaction of BadgerCare Plus Core Plan and Basic Plans with Federal HIRSP.

Blue Cross Blue Shield Conversion Funds: The Saga Continues!

Under the terms of a March 2000 order issued by the Office of the Commissioner of Insurance, Blue Cross Blue Shield United of Wisconsin converted from a not-for-profit hospital service insurance corporation to a for-profit, publicly held stock insurance corporation and provided \$630.4 million to endowments held by the Medical College of Wisconsin and the University of Wisconsin (UW) School of Medicine and Public Health. The Legislative Audit Bureau has conducted an evaluation of the Wisconsin Partnership Program and the Advancing a Healthier Wisconsin Program.

In a <u>full report</u> issued May 12, 2010, called "<u>Medical Education, Research, and Public Health Grants</u>," the auditors included the following recommendations for the Medical College of Wisconsin and the University of Wisconsin School of Medicine and Public Health to:

- · Ensure that project proposals include clear objectives before funds are awarded
- Improve project monitoring, including clarifying when grantees must notify program staff of modifications to project objectives
- Ensure that grant applicants disclose all external funding on their supplanting forms
- Clarify conflict-of-interest policies

In addition, the Audit Bureau offers the following recommendations (on page 93 of the report):

- The Medical College of Wisconsin include its unallowable cost policy in the guidelines for medical
 education and research grants
- The Commissioner of Insurance work with the Foundation and both medical schools to clarify several policy issues in order to ensure that funds are spent in a manner that is consistent with the intent of the order.

Public Health Money at Stake:

The Wisconsin United for Health Foundation Board (WUHF), the committee enlisted to oversee the conversion funds, will be meeting on July 15! We are calling on the public health community to let their voice be heard at this meeting! There is a lot of money out there; the conversion funds entrusted to the medical schools in Wisconsin hold significant opportunities for the public health of Wisconsin. The Legislative Audit Bureau has certainly raised questions about the administration and distribution of these funds. HealthWatch Wisconsin has weighed in with recommendations of its own, and is prepared to testify at the July 15 meeting. BadgerCare Plus Basic Plan: Coverage Begins!

July 1st is the first day of coverage for those individuals on the BadgerCare Plus Core Plan waiting list eligible and able to apply for the Basic Plan on June 1. The first month of coverage is conditioned on the

Department is moving forward with a number of changes to the W-2 program that are required as part of the Voluntary Compliance Agreement (VCA) between the Department of Children and Families and the US Department of Health and Human Services, Office for Civil Rights (OCR). One of the primary areas of focus in the VCA is to ensure that W-2 agencies provide reasonable accommodations to persons who have disabilities as required under Title II of the Americans with Disabilities Act (ADA) of 1990.

Operations Memo 10-49: Policy Changes for W-2 Trial Jobs (Released July 1)

New Policy: The purpose of this memo is to explain changes in policy and employer reimbursement for W-2 Trial Jobs.

Operations Memo 10-48: Disability Determination for PACE and

Partnership (Released June 28) New Policy: Individuals under age 65 who are eligible for certain categories of full-benefit Medicaid that do not require a disability determination (e.g., BadgerCare Plus Standard Plan, Well Woman Medicaid, Adoption Assistance Medicaid or Foster Care Medicaid etc.) are required to obtain a disability determination in order to be enrolled in the Home- and Community-Based Waivers under Group A eligibility rules. Family Care policy changed in September 2009 (see Ops Memo 09-51) to allow individuals eligible for these Medicaid programs to enroll without a disability determination. PACE and Partnership policies are now being aligned with Family Care.

Provider Updates

Durable Medical Equipment Place of Service Codes for Members Residing in a Facility for Developmental Disabilities

Facilities for developmental disabilities (FDD), are reimbursed through their daily rate for durable medical equipment (DME) reasonably associated with the care of residents, such as manual wheelchairs. Reimbursement for some specialized DME items, such as powered mobility equipment and custom wheelchair positioning systems, is not included in the daily rate. These items may be separately reimbursable when medically necessary and when prior authorized by ForwardHealth.

July 2010 Preferred Drug List Review and Other Pharmacy Policy Changes

This ForwardHealth Update provides an overview of the changes to Preferred Drug List (PDL) drug classes. Providers may refer to the following resources on the Pharmacy page of the <u>ForwardHealth Portal</u> for the complete list of preferred and non-preferred drugs for drugs covered by the benefit plan: The Wisconsin Medicaid, BadgerCare

acceptance of the first premium payment. Details of enrollment and eligibility are summarized below:

Monthly Premiums and Enrollment Dates

- All members must pay a premium of \$130 per person, per month for coverage in the Basic Plan.
- Enrollment in the Basic Plan always starts on the 1st of the month. Which month coverage starts depends on when you pay the first premium.
- If your first premium is received before 4:30 p.m. on the 15th of the month, your enrollment will start on the first of the next month.
- If your first premium is received after 4:30 p.m. on the 15th of the month, enrollment will be delayed a month.
- For example: If you sign up and pay your first premium between June 1 and June 15 by 4:30 p.m., your coverage will start July 1. If you sign up and pay your first premium between June 15 at 4:30 p.m. and June 30 by 4:30 p.m., your coverage will begin on August 1.
- Ongoing Monthly Premiums Each month members will get a premium payment slip in the mail. Your full premium payment will be due on the 5th of each month for coverage the next month. These premiums can be paid through the mail using the premium payment slip.
- Late Payment/No Payment If you fail to pay your monthly premium in full by the 5th of the month, your coverage will end and you will not be able to re-enroll in the Basic Plan for 12 months.

How To Enroll

To enroll in the Basic Plan, you must be on the Core Plan Waiting List. It's not too late to join the growing waiting list! To do so, either "Apply for Benefits" online or call the Enrollment Services Center at 1-800-291-2002. You will get a letter to confirm you have been placed on the list.

If you are *already* on the Waiting List, you don't need to do anything right now. In a few weeks, you will receive a fact sheet and instructions on how to enroll in Basic. Members

Once Enrolled in the Basic Plan, Individuals Will...

- Stay enrolled in this plan as long as premiums are paid and they are on the Core Plan waitlist and meet the Core Plan rules.
- Be invited to enroll in the Core Plan as openings are available based on funding and in the order in which they applied.
- Not be enrolled in an HMO.
- Potentially be asked to verify income and/or insurance coverage information.
- Be asked to report changes.

BadgerCare Plus Core Plan Renewals

Help Find Core Plan Enrollees; Help Them Renew!

Individuals who registered for BadgerCare Plus Core Plan in June of last year are coming up for renewal!

- Current enrollees will get a letter in the mail that will indicate "it is time to renew" Core Plan benefits.
- Renewal applications must be submitted in the "renewal month" or the following month
- If not submitted in time, the individual will have to apply for the waiting list.
- Step 1: Start the Renewal Application within the first 5 days of the renewal month.
- Step 2: Submit the Renewal Application by the end of the renewal month or the following month
- Step 3: 30 days to pay the \$60 fee
- Step 4: 30 days to provide the required verifications
- NOTE: Even if all the steps are completed "in time," any steps completed after the month following the renewal month will create a gap in eligibility.

Tips for Individuals with Core Plan Renewals:

- Members should get their physical before the end of their renewal month
- Make sure address is current
- Change address either by calling the Enrollment Service Center (ESC) or by filling out a report in your
 "MyACCESS" account
- Check the due date of renewal on the MyACCESS account page
- Renewal notices should have been mailed 45 days before its due date
- If you have any questions about the renewal process, please start with looking at the renewal chapter in the <u>ACCESS Handbook</u>.

How the new renewal dates were determined:

- A Core Plan member with Foodshare will have a renewal date synced with their next Foodshare renewal.
- A Core Plan member without Foodshare will have a renewal date of 1 year + 1 month from when their benefits were confirmed (the previous year).
- A Core Plan member with Family Planning Waiver benefits, the FPW renewal date will be synced with the new Core Plan renewal date.

Wisconsin's Department of Health Services will be running a list of Core Plan member's renewal dates available to community access point partners. To receive this list, email <u>Claire Smith</u> with your name, organization name, and community access point number. The list will be sent out when it is available, within the next month or so.

3 Things You Can Do TODAY To Improve Health Literacy!

What is Health Literacy?

"When is my next appointment scheduled?" "How frequently should I take my medication?" "Is my visit covered by my insurance or am I eligible for this hospital's charity care program?" Understanding the answers to these frequently asked questions is a measure of health literacy. Many hospital patients do not understand what professionals consider "basic health care information." We all can do a better job of talking in **plain language** and making sure our **patients understand**.

According to the Institute of Medicine report *Health Literacy: A Prescription to End Confusion*, literacy skills are the strongest predictor of an individual's health status-more than age, income, education level, employment status or racial or ethnic group. An estimated 36% of Americans have poor health literacy skills and cannot use a graph to determine a healthy weight range, or read labels to identify substances that interact with over-the-counter medications. Multiple state and national studies link higher health care costs to low literacy skills. Between \$106 and \$238 billion is lost each year on health care costs due to a problem with communication methods and the ability of adults to obtain, process and understand health information. Providers in Wisconsin lose \$3.4 billion annually due to health literacy problems. In Dane County alone, lack of health literacy costs the health care system more than \$433 million.

What Can You Do Today?

- Slow down, and ask questions!
 - Although it may seem inconvenient at the time, asking questions and taking a few extra minutes to understand will be a time-saver and money-saver for the patient, hospital, and more in the long run.
- Utilize strategies and tips included in toolkits and resources such as the ones listed here, in order to fill in gaps in communication that may cause unnecessary confusion and frustration:

CASE TIP: Reconciling New Health Coverage Laws with Health Reform **Provisions**

Michelle's Law: Six Months Later...

Michelle Morse, a Plymouth State University student, took a full schedule of college classes even after she was diagnosed with colon cancer just to keep her health insurance. Her struggle generated powerful federal legislation to keep dependent children from losing group health coverage through a parent if they drop out of school because of illness. What started as "HB 37," an amendment to the Employee Retirement Income Security Act (ERISA), soon became more familiarly known as "Michelle's Law." Effective January 1, 2010 for calendar year group health plans, the Law protects college students on a medically necessary leave of absence or reduced schedule from being kicked off their parent's insurance plan.

But, with national health reform including dependent coverage up to age 26, will Michelle's Law soon become obsolete?

Michelle's Law will be largely pre-empted by new regulations under Health Reform, (the Patient Protection and Affordable Care Act) which requires plans to provide continuous eligibility for all children under age 26 on family plans, regardless of their schooling or dependent status. To make sure there are no gaps in coverage for families, group health plans will continue to operate as they are right now-adhering to provisions under Michelle's Law until the dependent coverage at age 26 rules go into effect for plan years after Sept. 23, 2010.

Once dependent coverage is the rule of the land, "student status" will be a moot point. But where is the confluence of Michelle's Law and Health Reform unclear? We can picture a few scenarios involving adding a dependent back to a employer-sponsored plan. (The editors of the Update will keep a watch and share scenarios with you as they play out.)

Keep in mind: Wisconsin's dependent coverage law requiring health insurance policies to cover eligible young adults up to age 27. The law applies to individual health and group health benefit plans and a selfinsured plan of the state, or a county, city, village, town or school district, including limited scope plans, such as vision and dental plans. However, the law does not apply to non-state regulated, self-funded coverage plans, which officials say make up roughly 40 percent of Wisconsin's insurance. The statute went into effect for health insurance policies issued or renewed beginning on Jan. 1, 2010, the same time as the federal act, Michelle's Law.

Grapevine: \$40M in Section 8 Housing and Urban Development Vouchers for People with Disabilities

The U.S. Department of Housing and Urban Development has recently made available \$40 million worth of Section 8 Housing and Urban Development Vouchers for non-elderly people with disabilities. The deadline for submitting an application is Wednesday, July 7 and applications must be submitted by a Wisconsin Public Housing Authority.
