

## Health Care and Coverage A Priority for Wisconsin's Legislative Council

The Legislative Council is charged to conduct studies of matters of concern to the Legislature, either during or between sessions of the Legislature, and to report its recommendations to the next general or special session. The Legislative Council is one of five nonpartisan legislative service agencies of the Wisconsin Legislature. The duties of the Legislative Council are:

- To provide nonpartisan legal, scientific and other research services and administrative support services to Joint Legislative Council study committees and other legislative standing committees and task forces;
- To serve as the Rules Clearinghouse for review of all proposed administrative rules; and
- To respond to research and information requests from legislators, legislative staff, other governmental agencies and other state legislatures in a confidential and nonpartisan manner.

Special committees have been formed to tackle important health care and coverage issues facing Wisconsin. Four are chronicled here. Stay tuned to the HealthWatch Reporter for a feature story on some of these committees, reaction to the first meeting, and a look ahead for 2010-2011. *More detail and attachments on each of the committees is located in this newsletter, at left, in the section titled "Detail and Attachments."* 

#### 1. 2010 Interim Study Committee on Health Reform Meets in Madison

On August 19, the 2010 "Interim Study Committee on Health Care Reform Implementation" met in Madison at the State Capitol Building. The Special Committee was directed to study and make recommendations on what changes should be made to Wisconsin's statutes and administrative rules in response to recently enacted federal health care reform legislation. The committee was directed to study all aspects of the federal legislation that affect Wisconsin including insurance market reforms, coverage for uninsured persons, preventive care, taxation, quality improvement, and health workforce issues.

#### 2. Special Committee on Health Care Access Discusses Doctor/Nurse Shortages

This Special Committee, meeting for the first time on August 24 at the Legislative Council offices, was ready and eager to study potential solutions to the shortage of health care providers, particularly in rural areas and inner cities, and the adequacy of funding for public health. The Special Committee was directed to study possible state assistance to underserved areas and an expansion of Wisconsin's capacity for training family practice physicians and nurses, and additional funding sources for public health.

#### 3. Special Committee on Review of Emergency Detention and Admission of Minors Under Chapter 51

August 31 was the first meeting if the new 2010 Interim Study Committee on emergency detention and admission of minors under Chapter 51. Led by Rep. Sandy Pasch and Sen. Dave Hansen, this Special Committee is directed to review the following provisions in ch. 51, Stats.: (a) the appropriateness of, and inconsistencies in, the utilization of emergency detention

procedures under s. 51.15, Stats., across this state, and the availability and cost of emergency detention facilities; (b) the inconsistent statutory approaches to emergency detention between Milwaukee County and other counties in the state; and (c) the inconsistent application of procedures relating to admission of minors under s. 51.13, Stats., as modified by 2005 Wisconsin Act 444.

#### 4. Special Committee on Infant Mortality Meets September 8 at the State Capitol

The legislative council has created a special committee to study (a) the causes of infant mortality in Wisconsin; (b) evaluation of efforts that have been undertaken to address this problem in both the private and public sectors; (c) coordination of public health and Medicaid funding; (d) evaluation of infant mortality prevention programs that have been successful in other cities and states; (e) evaluation of the public health costs of not addressing the causes of infant mortality in Wisconsin; and (f) developing a strategic proposal, including any necessary legislation, to address infant mortality in Wisconsin, particularly disparities in infant mortality rates in different geographic areas of the state.

## Making The Family Planning Waiver Permanent

### Wisconsin Plans to Expand the Family Planning Waiver

Since 1972, States have been required to provide family planning services and supplies to Medicaid populations. Prior to this Spring, States did not have the option to provide these same family planning services and supplies under their Medicaid State plans to individuals otherwise ineligible for Medicaid, including parents with incomes above State eligibility levels and non-disabled adults who were not caring for children. Yet, providing these family planning services has been found to be extremely cost effective for the Medicaid program. Therefore, the Secretary of Health and Human Services has granted targeted "section 1115 family planning demonstrations" to permit States to cover family planning services and supplies for individuals not otherwise eligible for Medicaid. With the enactment of health reform, States now have the option to offer, under State plan authority, eligibility for family planning coverage for individuals who were previously ineligible for Medicaid. Up until this point in time, funding for Wisconsin's Family Planning Waiver has been conditional, and the state has had to regularly reapply for funding. Now, Wisconsin can make its plan permanent, which means it will also get its federal funding much faster. In June of 2010, Wisconsin applied to the federal government to raise the qualifying income limit to \$32,490, which would mean a significant expansion in the number of individuals who could receive services. Wisconsin's Medicaid Director Jason Helgerson talked with the Wisconsin News Service's Bob Hague about the potential expansion.

#### A Refresher on Wisconsin's Family Planning Waiver

This plan provides certain family planning services to women ages 15 through 44. The purpose of this plan is to stop unplanned pregnancies and sexually transmitted diseases. Federal law allows members to choose a provider, including physicians and family planning clinics, for family planning services and supplies. Individuals can also go to any family planning clinic that will accept a ForwardHealth ID card, even if the clinic is not part of the individual's HMO.

#### **Current Eligibility**

- An individul must be a U.S. citizen, or have proof of immigration status,
- Age 15 through 44,
- Not be getting ForwardHealth for the Elderly, Blind or Disabled or BadgerCare Plus Standard or Benchmark Plans, and
- Have a family gross income of no more than 200% of the federal poverty level (For minors, parents' income is not counted).

#### Family Planning Waiver for Men

Remember, effective May 1, 2010, the Family Planning Waiver Plan provides certain family planning services to men ages 15 through 44. The primary purpose of this plan is to prevent unplanned pregnancies. So, the covered services are limited to family planning and related services like the testing and treatment of sexually transmitted diseases/infections (STDs/STIs).

#### A Closer Look at Family Planning in Health Reform

Health reform has made it possible for a new, expanded Medicaid eligibility group. States have the option to begin providing medical assistance for family planning services and supplies to individuals eligible under this new group. <u>Under this new option</u>, Federal funding will be

## **ACCESS Handbook Updated**

Below. On August 5, Wisconsin's

available for States to provide coverage under the State plan for family planning and family planning-related services and supplies to individuals (men and women) that States could previously offer only through demonstration projects.

**New Eligibility Group:** These eligible individuals are those who are not pregnant and whose income does not exceed the income eligibility level established by the State.

**Benefits Available:** Services are limited to family planning services and supplies, as well as medical diagnosis and treatment services that are provided pursuant to a family planning service in a family planning setting.

**Presumptive Eligibility Period:** begins with the date on which the qualified entity determines that the individual is eligible based on preliminary information. This period ends with and includes the earlier of:

- The day on which a formal eligibility determination is made for the family planning program under the Medicaid State plan; or
- For an individual who does not file an application by the last day of the month following the month during which the individual was determined presumptively eligible, the last day of that month is the last day of the presumptive eligibility period.

# Hidden in Health Reform Legislation...

## ... Enhanced Adoption Assistance!

Health Care Reform, a.k.a., the Patient Protection and Affordable Care Act increased the employer-provided adoption assistance exclusion and the adoption tax credit each to \$13,170 for all adoptions, including adoptions of children with special needs. In addition, health reform allows for the credit and exclusion to be adjusted for inflation beginning Jan. 1, 2011. That adjustment is made by multiplying the statutory limit by the cost of living adjustment for the calendar year in which the tax year begins. Employers that offer adoption assistance and employees who take advantage of it — or that claim the adoption tax credit — need to make adjustments, as the legislation that changed the thresholds for adoption assistance is retroactive to January 1, 2010.

## Refresher on Adoption Assistance in Wisconsin:

To be eligible for assistance, a child must have, or be at risk of developing special needs and otherwise would not be able to be placed for adoption without adoption assistance. <u>Adoption</u> <u>assistance</u> is determined by the special care needs of the child and may include:

- Medical assistance for some medical costs not covered by the family's health insurance;
- A monthly amount to the adoptive parent(s) to assist in meeting the financial demands of caring for a child's special care needs; and
- Reimbursement of reasonable and necessary expenses incurred in order to complete the adoption (e.g., legal fees and/or agency fees)

Eligibility criteria for the child, as defined in <u>Wisconsin Administrative Code DCF 50</u>, Facilitating the Adoption of Children with Special Needs is:

- 10 to 18 years of age;
- Exhibiting emotional, behavioral or physical/personal care characteristics to a degree that meets established criteria;
- Member of a sibling group of three or more who must be placed together;
- Member of a minority race who cannot be readily placed due to a lack of appropriate placement resources; or
- At risk of developing special care needs

#### **Provider Updates**

#### Non-emergency Transportation Is Now Covered by the BadgerCare Plus Benchmark Plan

Due to changes in federal regulations, effective for dates of service (DOS) on and after July 1, 2010, the BadgerCare Plus Benchmark Plan will cover nonemergency transportation. Nonemergency transportation can be provided by common carrier and by specialized medical vehicle (SMV) providers.

#### Reminder Regarding Charging Members Fees for Health Care Records

Providers are reminded that, per s. 146.83, Wis. Stats., they **may not charge a fee** for providing one set of copies of health care records to members who are enrolled in Wisconsin Medicaid or BadgerCare Plus programs.

#### ClaimCheck Clarification

This ForwardHealth Update provides clarification of ForwardHealth's use of ClaimCheck review software in the claims processing system. ForwardHealth uses ClaimCheck software to review all professional claims. Information in this Update applies to providers who render services to Wisconsin Medicaid and BadgerCare Plus members. ForwardHealth monitors all professional claims for compliance with reimbursement policy using automated procedure coding review software known as McKesson ClaimCheck®. ClaimCheck reviews submitted claims for billing inconsistencies and errors during claims processing. Insurance companies, Medicare, and other state Medicaid programs use similar software. ClaimCheck review does not change Medicaid or BadgerCare Plus policy on covered services but monitors compliance with policy more closely and reimburses providers appropriately.

#### Reminders and More Information about Important Changes for Private Duty Nursing Providers

Effective for dates of service (DOS) on and after May 1, 2010, ForwardHealth implemented important changes for providers of private duty nursing (PDN) services to members who are enrolled in

- The Wisconsin Adoption Assistance Program administered through the Department of Children and Families:
  - Visit the Department's web site.
  - o Contact a licensed Wisconsin adoption agency;
  - Contact the Toll Free Number at 866-666-5532 in the Division of Safety and Permanence, Department of Children and Families.

## Medicaid Follow-up: States Must Ask for the Money!

In the last edition of the HealthWatch Update, we brought you a story called **"Boost to Medicaid and BadgerCare Plus Coming to Wisconsin,"** chronicaling the passage of <u>HR</u> <u>1586, the Education Jobs and Medicaid Assistance Act</u>, which was quickly signed into law by President Barack Obama. The Education Jobs and Medical Assistance Act will provide states with a total of \$26 billion for teachers and health care programs. For Wisconsin, the impact could be as large as \$365 million, with just over half (\$185 million) going to Medicaid programs and the remaining \$180 million to prevent teacher layoffs. The funding is necessary to relieve an estimated \$647 million out of an \$850 million deficit in Wisconsin's budget for BadgerCare Plus and other Medicaid programs. The funding preserves additional federal matching money. The legislation was approved mainly along party lines by a vote of 247-161.

On August 19, 2010, Department of Health and Human Services Secretary Kathleen Sebelius sent a letter to all of America's governors telling them that if they want to continue receiving the enhanced Medicaid funds that Congress approved, **they have to ask for the money**. CHASE is also considering revitalizing an active HealthWatch meeting to discuss direction and

the BadgerCare Plus Standard Plan and Medicaid. This ForwardHealth Update pertains to information originally published in the March 2010 Update (2010-15), titled "Important Changes for Private Duty Nursing Providers," which introduced and detailed these changes. This Update includes reminders about certain important changes for PDN providers and more information about preparing claims for services provided on days when clocks are adjusted to accommodate changes to daylight-saving time. Note: The online handbook has not been revised to incorporate changes included in this Update

#### **Reminder of Deficit Reduction Act** Policy for Prescribers

This ForwardHealth Update reminds prescribers of the claim submission requirements of the Deficit Reduction Act of 2005. Under the Deficit Reduction Act of 2005 (DRA), providers are required to submit National Drug Codes (NDCs) with Healthcare Common Procedure Coding System (HCPCS) procedure codes on claims for provideradministered drugs. Section 1927(a)(7) (B) of the Social Security Act requires NDCs to be indicated on all claims submitted to ForwardHealth, including Medicare crossover claims. If an NDC is not indicated on a claim submitted to ForwardHealth, or if the NDC indicated is invalid, the claim will be denied. Radiopharmaceuticals are included in the DRA requirements. Providers will be required to indicate NDCs with HCPCS procedure codes on claims for radiopharmaceuticals.

#### Deficit Reduction Act Policy for End-Stage Renal Disease Services Providers

This ForwardHealth Update reiterates the Deficit Reduction Act of 2005 (DRA) policy for end-stage renal disease (ESRD) providers who submit claims for provider-administered drugs. Effective for dates of service on and after September 15, 2010, ForwardHealth is enhancing claims processing for ESRD claims for provider-administered drugs to ensure claims contain all information that is required under the DRA. Under the DRA, providers are required to submit National Drug Codes (NDCs) with Healthcare Common Procedure Coding System (HCPCS) procedure codes on claims for provideradministered drugs. Section 1927(a)(7) (B) of the Social Security Act requires NDCs to be indicated on all claims submitted to ForwardHealth, including

Medicare crossover claims. If an NDC is not indicated on a claim submitted to

## Attention Local Public Health Departments:

Opportunities exist to form new, sustainable HealthWatch Coalitions. ABC for Health, Wisconsin's Department of Health Services, and HealthWatch Wisconsin are helping to support a sustainable, inter-connected network of new community-based HealthWatch Coalitions to promote access to and retention of health care coverage for children. Coalitions are strongly encouraged to include local health departments as the key stakeholder. Your County can create a coalition to develop a sustainable plan to connect and maintain family connections to health coverage, care, and resources.

## **Getting Started:**

Start by identifying community partners and leaders, including representatives from hospital systems, Head Start, parents, Birth-to-3 Coordinators, public health nurses, economic support workers, school nurses and counselors, advocates, employers, and members of the faith community. Then, watch for an RFP! The Wisconsin Department of Health Services and HealthWatch Wisconsin will issue a call for proposals to invite coalitions to compete for funding. We will prioritize coalition development for low-enrollment, under-performing or health disparity locations across Wisconsin. In fact, HealthWatch Wisconsin will prioritize coalition development where local health departments take a leading role. After funding, HealthWatch Wisconsin will continue to help with ongoing technical consultation and leadership training. We will be looking for areas that can DEVELOP and SUSTAIN a coalition, after the start-up assistance is complete.

# CASE TIP: It's Back to School for College Students!

An estimated 19 million college students will be enrolling in classes this fall<sup>1</sup>, and as many as 12%<sup>2</sup> students may be uninsured. With several provisions of federal health reform legislation coming into effect on September 23, 2010, college students and their parents may not fully understand their health insurance options. Please take some time to review the following three "Frequently Asked Questions" to help this year's students find the best health insurance solution for their health needs and personal budget:

#### 1. Question: Do I need to have health insurance when I go to school?

Answer: Most colleges and universities require students to have some kind of health insurance coverage. Students may contact their school for more information, but should keep in mind that health insurance is about more than getting access to health care when you need it. It also helps limit financial liability for expenses that may arise from an unforeseen accident or injury -- expenses that could potentially bankrupt the students or their parents, or your parents and seriously damage credit scores or prospects for the future. Whether or not the school requires it, make sure your student is covered!

#### 2. Question: What are the health insurance options students can choose from this year?

Answer: Most college students in 2010 will choose from among the following five types of health insurance coverage:

· Parents' health insurance plans. A provision of federal health reform law that becomes effective in 2010 allows adult children to keep their coverage under a parent's health insurance policy until age 26, whether or not they are currently enrolled in college. The parent's policy might be group coverage sponsored through an employer or an individual or family policy purchased by the parent. Some employer-based plans are accepting students now while others may wait until January 1, 2011 before allowing students to re-enroll. Please note that Wisconsin has its own dependant coverage law, which provides coverage for adult children until the age of 27. Please click here for

ForwardHealth, or if the NDC indicated is invalid, the claim is denied.

#### BadgerCare Plus Basic Plan Members Diagnosed with Cancer May Be Enrolled in the BadgerCare Plus Core Plan

Effective immediately, members enrolled in the BadgerCare Plus Basic Plan who are diagnosed with cancer, excluding non-melanoma skin cancers, may bypass the waitlist and apply for the BadgerCare Plus Core Plan. The diagnosis of cancer may be a new diagnosis since the member was enrolled in the Basic Plan or it may be a pre-existing condition.

#### Changes to Assistant Surgeon Policy

Effective for dates of service on and after September 1, 2010, ForwardHealth will revise the list of procedure codes for which it reimburses assistant surgeon services to be consistent with national standards (recommendations from McKesson ClaimCheck® automated procedure coding review software). ForwardHealth currently accepts four assistant surgeon modifiers; this is a revision to previously published policy that identified only one acceptable modifier. ForwardHealth monitors all professional claims for compliance with reimbursement policy using ClaimCheck. ClaimCheck recommends whether assistant surgeon services for surgery procedures should never or always be reimbursed. The American College of Surgeons is ClaimCheck's primary source for determining assistant surgeon reimbursement recommendations.

more information on that coverage option for insurance plans governed by the law of Wisconsin.

- Individually-purchased health insurance plans. Many students purchase coverage on their own in the form of an individual, non-group policy. There is a broad variety of individual coverage options to choose from nationwide. However, until 2014, in most states it is still possible to be declined for individual coverage based on pre-existing medical conditions.
- School-sponsored health plans. Many colleges and universities offer their own health insurance plans to students. Some of these plans place strict limits on the range of benefits covered and may limit access to only those doctors and services available through an on-campus student health center. As regulations for health reform laws continue to be written, the future of school-sponsored plans is uncertain.
- Individually-purchased student health plans. These plans may resemble schoolsponsored plans by placing specific limits on certain benefits, but they typically offer more freedom in obtaining medical care away from campus. Student health plans may be especially valuable for those going to school in a different state. While the postreform future of these products is also uncertain, new and innovative student health plans with richer benefits are being introduced to the market.
- Government insurance options. These may include state or federal insurance programs such as Medicaid or high risk pools (such as Wisconsin's HIRSP plans, available <u>online</u>. In order to qualify for some of these products enrollees must have a diagnosis for a pre-existing medical condition on file with their doctor. In some instances, the enrollee may also need to have been previously uninsured for a minimum of six months.

# 3. Question: What should a student do if she can't re-enroll in her parents' plan until January 2011?

**Answer**: The provision of federal health reform that allows adult children to stay on their parents' plan comes into effect on September 23, 2010. However, due to open enrollment schedules, some employer-based plans may not allow you to re-enroll in a parent's plan until January 2011. If students need a stop-gap to provide coverage until then, they may consider purchasing an individual health insurance plan, which can be paid month-to-month and cancelled at any time. Short-term health insurance plans offer another solution, but please note that short-term plans typically don't cover preventive care, pre-existing medical conditions or prescription drugs.

# Grapevine: Will Health Reform Hurt Policies Colleges Offer Students?

School is back in session this week for many colleges and universities! Confusion is running rampant about how the new health reform law affects college health plans. Julie Appleby, reporter for Kaiser Health News, has looked into the new health reform rules and explored why colleges and universities fear they will no longer be

able to offer low-cost, limited benefit student insurance policies. School representatives suggest that they will try to continue to offer affordable, low cost plans for students. These plans have taken some heat for offering insufficient coverage, encouraging critics to suggest the schools' student health plans to be held to the same standards as other insurance. More importantly, colleges want to be sure they are not required to offer policies to non-students.

What do you think? Should school plans be offered any special protection in the regulations now being developed to implement the health reform law? Is it in the best interest of our students to continue to protect lower premiums, or to ensure a higher quality coverage consistent with other "individual policies?" <u>Send us an email</u> with your thoughts. Health and Human Services Secretary Kathleen Sebelius will be offering her ideas on this topic in the near future, via letter to the American Council on Education. We'll keep you posted on how this conversation develops in future editions of the Update.
