Study Committee Schedules Two Meetings for October:

[The Legislative Council Special Committee on Health Care Access](#) has been directed to study possible state assistance to underserved areas and an expansion of Wisconsin's capacity for training family practice physicians and nurses, and additional funding sources for public health. A significant effort to accomplish this end is the study of solutions to the shortage of health care providers, particularly in rural areas and inner cities, and the adequacy of funding for public health. Individuals and organizations are encouraged to offer recommendations and solutions to address the robust, complex nature of the "lack of access" problem as presented. Our View: Access to Care Includes Access to Coverage

Access to quality, affordable health care often begins with access to comprehensive health care coverage. Health care reform has improved the availability of coverage for Wisconsin's residents; yet myriad barriers separate families and single individuals under the age of sixty from securing essential, affordable coverage. We need an advocacy presence to effectively navigate the changing systems of coverage and to receive timely and comprehensive coverage for residents. Legislative leadership addressed a similar issue, when in 1977, the elderly voiced a demand for advocacy that ultimately led to the successful creation of a supportive statewide network of Senior Benefits Specialists in Wisconsin. Accordingly, it is time to hear the voices of communities across the state for coordinated advocacy outreach and enrollment in health care coverage programs to ensure Wisconsin residents are linked to the health care coverage and services they need.

HIRSP Audit Shows Statistics on Enrollment and Financial Strength

On September 28, Wisconsin's Legislative Audit Bureau (LAB) released its [Report of the 2009 annual financial audit of the Wisconsin Health Insurance Risk-Sharing Plan \(HIRSP\) Authority](#). The introduction to the Report provided valuable statistics on enrollment and financial strength of HIRSP. Since its inception on July 1, 2006, [the HIRSP Authority](#) has maintained a sound financial position.



Plan Enrollment:

The HIRSP Authority provides medical and prescription drug insurance for individuals who are unable to obtain coverage in the private market or who have lost employer-sponsored group health insurance.

- Plan enrollment was 16,252 as of December 31, 2008, a decrease of 874 policyholders, or 5.1%, compared to enrollment of 17,126 as of December 31, 2007.
- During 2009 there was a slight increase of 129 policyholders, or 0.8%, in plan enrollment.
- There were 16,381 policyholders as of December 31, 2009.

Operations Memos

[Ops Memo 10-65](#) Milwaukee County Wisconsin Works (W-2) Participant Choice Policy (*released Sept. 23*)

New Policy: Beginning January 1, 2011, participants assigned to a Milwaukee W-2 Employment Agency (WEA) will be able to request a transfer to a different WEA if: his/her W-2 case opened before April 1, 2010; he/she has been at the current WEA for at least six months; he/she has special circumstances (homelessness, special needs related to domestic violence, mental or physical health issues that warrant a WEA change); or if he/she moves to a different region. SSIA participants may choose a WEA if the switch is determined appropriate.

[Ops Memo 10-71](#) Long Term Care Insurance Partnership Program--Reciprocity Standards (*released Sept. 21*)

New Policy: Participation in Wisconsin's LTCIP program is allowed for individuals who purchased qualified policies in any state that is subject to the LTCIP reciprocity standards as documented in that state's Medicaid State Plan.

- Approximately 500 of the individuals who left HIRSP in 2008 were children who qualified for the State's BadgerCare Plus program effective February 1, 2008. Because of their BadgerCare Plus eligibility, these children were no longer eligible for HIRSP and transitioned to BadgerCare Plus during the first quarter of 2008.
- During 2009, approximately 470 individuals left HIRSP as a result of the expansion of the State's BadgerCare Plus program to adults without children, which affected overall enrollment growth.

HIRSP After Federal Health Reform:

The 2010 health care reform legislation allocated each state a portion of the \$5 billion in federal funds provided for the temporary high-risk pool program and gave the federal Department of Health and Human Services (DHHS) 90 days to establish the program either directly or through contracts with states and nonprofit entities. In July 2010, DHHS contracted with the HIRSP Authority to implement the program in Wisconsin to provide access to insurance for individuals who are uninsured because of pre-existing medical conditions, called the HIRSP Federal Plan, which is expected to operate until 2014. HIRSP Plans are for individuals who have recently been insured, while the HIRSP Federal Plans are for individuals who have not been insured for at least six months. Wisconsin Partnership Program Annual Report is Released

The University of Wisconsin School of Medicine and Public Health, in coordination with the Oversight and Advisory Committee (OAC) and the Medical Education and Research Committee (MERC), has released the 2009 annual report of the [Wisconsin Partnership Program \(WPP\)](#). The report covers activities and expenditures from January 1, 2009, through December 31, 2009. It has been prepared in accordance with the Insurance Commissioner's Order; the Agreement between the Wisconsin United for Health Foundation, Inc. (WUHF), the University of Wisconsin Foundation, and the University of Wisconsin System Board of Regents; and the 2009-2014 Five-Year Plan. Each of these documents was created to guide the distribution of the funds resulting from Blue Cross and Blue Shield United of Wisconsin's conversion to a for-profit corporation.

Follow Up to Earlier Discussion in the HealthWatch Update: The Wisconsin United for Health Foundation Board

Many of our readers have been actively following the actions of the Wisconsin United for Health Foundation Board. The discussion has centered around a Legislative Audit Bureau Report, issued earlier this year, that evaluated how the UW medical school and Medical College of Wisconsin were doing, as stewards of the Blue Cross Blue Shield Conversion funds. The WUHF Board is in the process of scheduling their annual report meeting, to occur before the end of the calendar year. As a response to both the annual report and follow-up conversations on the WUHF Board and LAB, the Staff of HealthWatch Wisconsin is working on a new edition of the "HealthWatch Reporter." Wisconsin Awarded Exchange Planning Grant

The Department of Health Services was awarded \$999,873 by the US Department of Health and Human Services to design and build an insurance exchange ahead of

[Ops Memo 10-58](#) Electronic Case File (ECF) Workflow Phase 2 (*released Sept. 20*)

New Policy: Effective November 1, workers can use self-scanning, faxing and uploading to get documents to the ECF. The Document Tracking Sheet (DTS) must be used as a cover sheet while self-scanning or faxing documents to the ECF.

[Ops Memo 10-69](#) Enforcing the 40% Rule for Children of Child Care Provider Employees (*released Sept. 17*)

New Policy: Wisconsin Act 28 inhibits Wisconsin Shares reimbursements to employees of a child care provider if more than 40% of all children enrolled by the provider are children of employees of the provider. This memo explains how to determine if a provider is violating Wisconsin Act 28 through the Child Care Statewide Administration website and describes the six week notice to give to providers who are out of compliance. All authorizations for children of parents employed by the provider will be terminated if the provider does not comply.

[Ops Memo 10-70](#) Child Care Certification--Permanent Bar for False Information on BID Forms (*released Sept. 16*)

New Policy: Child care applicants who provide false (or withhold) information to the regulatory agency will permanently be barred. "False" here means intentionally or willfully untrue. If an applicant unintentionally gives misinformation or makes a mistake on the forms, that would not constitute a permanent bar..

health reform's 2014 deadline. On September 1, 2010, DHS submitted an proposal in response to CFDA Number: 93.525 State Planning and Establishment Grants for the Affordable Care Act's Exchanges. With the new award, DHS is funded to meet the following objectives:

- Design an Exchange that moves beyond an aggregator of health insurance options, to a mechanism that influences how health care is delivered in the State.
- Contract to develop a predictive model to measure the impact of the insurance market reforms on Wisconsin, coupled with other requirements of the Affordable Care Act.
- Maintain Exchange resource information on the Office of Health Care Reform web site to allow stakeholders to stay informed and provide input.
- Conduct surveys of the individual, small group, and large group markets, and model and analyze insurance reform impacts to assure clear understanding of Wisconsin's current and future health insurance landscape.

"Wisconsin sees the Exchange as a transformative force," states the DHS proposal to the Federal Government. The objective of the Wisconsin Exchange Planning Project is to complete the necessary research and analysis to establish the foundation for a successful implementation. Private Insurance Disputes after Health Reform: Internal and External Reviews

Digging into the Fine Print in October:

A new provision in federal health reform legislation requires group health plans and insurance companies to establish an **internal** claims appeal process and **external** review procedures for individuals who wish to contest denials of claims and benefit determinations. Notice of the available appeal options and access to an individual's file must also be provided to consumers. A lot of regulations and procedures govern both the internal and external review options for families and individuals. Keep in mind, there is a **grace period** to allow insurers to "get up to speed" on health reform provisions. During the applicable period, the Department of Labor and IRS will not take any enforcement action against a self-insured group health plan that complies with safe harbor provisions. Start by identifying community partners and leaders, including representatives from hospital systems, Head Start, parents, Birth-to-3 Coordinators, public health nurses, economic support workers, school nurses and counselors, advocates, employers, and members of the faith community. Then, watch for an RFP! The Wisconsin Department of Health Services and HealthWatch Wisconsin will issue a call for proposals to invite coalitions to compete for funding. We will prioritize coalition development for low-enrollment, under-performing or health disparity locations across Wisconsin. In fact, HealthWatch Wisconsin will prioritize coalition development where local health departments take a leading role. After funding, HealthWatch Wisconsin will continue to help with ongoing technical consultation and leadership training. We will be looking for areas that can DEVELOP and SUSTAIN a coalition, after the start-up assistance is complete.

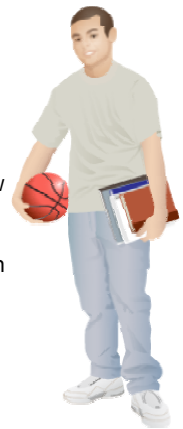

CASE TIP: Dependent Coverage of TriCare

No Change to TriCare Dependent Coverage Policies After Health Reform

TriCare is a health care program serving over 9.6 million active duty service members, National Guard and Reserve members, retirees, their families, survivors and certain former spouses worldwide. TriCare "brings together the health care resources of the uniformed services and supplements them with networks of civilian health care professionals, institutions, pharmacies and suppliers," according to [TriCare.Mil](#), the official website of the TRICARE Management Activity (a component of the Military Health System). Currently, dependent children may remain on their parents' TriCare policies until age 21, or age 23 for full-time students who rely on their parents for more than 50% of their support. TriCare was specifically excluded from federal health reform legislation that expanded coverage for dependents to age 26.

Dependent Coverage: As a reminder, a provision of federal health reform law that becomes effective in 2010 allows adult children to keep their coverage under a parent's health insurance policy until age 26, whether or not they are currently enrolled in college. The parent's policy might be group coverage sponsored through an employer or an individual or family policy purchased by the parent. Some employer-based plans are accepting students now while others may wait until January 1, 2011 before allowing students to re-enroll. Please note that Wisconsin has its own dependant coverage law, which provides coverage for adult children until the age of 27. Please [click here](#) for more information on that coverage option for insurance plans governed by the law of Wisconsin.



TriCare is not impacted by health reform, so the TriCare policy for dependent eligibility has not changed. The reason for not including TriCare in reform legislation was part administrative and part political.

Legislation to Watch: Legislation has been *introduced* to change the rules of TriCare and CHAMPVA benefits to mimic health reform dependent coverage rules. Two bills, HR 4923 and S. 3201, both titled, The TRICARE Dependent Coverage Extension Act (one in the House, one in the Senate) were wrapped into the [National Defense Authorization Act for 2011](#). The bill passed the House, but the companion bill failed a [cloture motion](#), preventing consideration of the bill in the Senate by roll call vote. The Senate failure is speculated to be due to the other add-ons to the bill that are more controversial (including the DREAM Act and Don't Ask, Don't Tell provisions.) All this political movement is pretty recent—the Senate vote to hear debate on the Defense Act was just last week. Watch future editions of the Update for developments on this and related legislation.

Grapevine: Changes to BadgerCare Plus Standard Plan Preferred Drug Listing



In the September ForwardHealth Provider Update, a [Fall 2010 Preferred Drug List](#) was announced. The Online Handbook has not yet been updated to reflect the information found in the Update, but we are able to get an idea of the new Preferred Drug List for dates of service on or after October 1, 2010. This impacts BadgerCare Plus Standard Plan, Medicaid, and SeniorCare, and does not impact Benchmark Plan, Core Plan or Basic Plan (unless noted). Changes in status may have occurred to preferred and non-preferred drugs. The Staff of HealthWatch Wisconsin is reviewing the new Drug List and changes to be able to help patients identify any changed coverage.

Provider Updates for September

ForwardHealth Updates are regularly made available to Wisconsin Providers. We have selected a few key updates and summarized them below. For more information or to view additional updates, please visit the [ForwardHealth Provider Portal](#).

[Present on Admission Indicator Required for Additional Hospital Providers](#)

Effective for dates of discharge on and after October 1, 2010, Wisconsin Medicaid and BadgerCare Plus are expanding the types of hospital facilities/providers that are required to include present on admission (POA) indicator information for all primary and secondary diagnoses to include: Critical access hospitals and Children's hospitals. Claims will be denied if the POA indicator is not present on claims with dates of discharge on and after October 1, 2010. Additionally, reimbursement may be affected by this requirement. Critical access hospitals and children's hospitals were previously exempt from this requirement as stated in the December 2009 ForwardHealth Update (2009-93), titled "Present on Admission Requirements for Inpatient Hospital Claims." This policy is an extension of the BadgerCare Plus and Medicaid rate reform cutbacks to improve quality and control costs.



[2010 Rate Changes for School-Based Services](#)

Effective for claims processed on and after October 1, 2010, federal share reimbursement rates for school-based services (SBS) will be 60.16%. The information in this ForwardHealth Update applies to members enrolled in Wisconsin Medicaid, the BadgerCare Plus Standard Plan, and the BadgerCare Plus Benchmark Plan.

[ForwardHealth Holiday and Furlough Day Schedule](#)

ForwardHealth will be closed for business in recognition of certain holidays and in accordance with state furlough days occurring in calendar year 2010 and 2011, which will affect call center and other resources' availability as well as payment review and approval. The holiday and furlough day schedule is provided in this ForwardHealth Update.

[Rate Changes for Case Management Services](#)

Effective for claims processed and paid on and after October 1, 2010, the federal share will decrease from 60.21% to 60.16% for case management services, although the reimbursement amount for these services will not change. Wisconsin Medicaid will pay up to the federal share of the contracted rates for these services. If the provider's usual and customary charge for the service is less than the contracted rate, Wisconsin Medicaid will pay the federal share of the usual and customary charge.

[Prior Authorization Is Required for Certain Durable Medical Equipment Under the BadgerCare Plus Core Plan and the BadgerCare Plus Basic Plan](#)

Prior authorization (PA) is required under the BadgerCare Plus Core Plan for certain durable medical equipment (DME) services. Prior authorization policy for the Core Plan is the same as the PA policy for Medicaid and the BadgerCare Plus Standard Plan with the exception of non-preferred diabetic supplies. Non-preferred diabetic supplies are not covered under the Core Plan and PA requests will be returned to providers. The PA policy is effective for dates of service (DOS) on and after January 1, 2009, and clarifies policy published in the December 2008 ForwardHealth Update (2008-211), titled "Durable Medical Equipment Covered Under the BadgerCare Plus Core Plan for Childless Adults."



Certain Inpatient Hospital and Nursing Home Claims Processed Incorrectly

Certain inpatient hospital claims submitted since ForwardHealth interChange implementation may have been incorrectly denied due to a system error. In addition, effective for dates of process on and after October 1, 2010, nursing home claims will be denied if covered and noncovered days and accommodation units are not indicated correctly. This ForwardHealth Update outlines the denials and provides information regarding claims submission, including timely filing requests.

Fall 2010 Preferred Drug List Changes

This ForwardHealth Update provides information for prescribers and pharmacy providers about changes to the Preferred Drug List effective for dates of service on and after October 1, 2010. BadgerCare Plus, Medicaid, and SeniorCare have added three new drug classes to the Preferred Drug List (PDL) and reviewed 41 existing drug classes. Changes in status may have occurred to preferred and non-preferred drugs. Changes to the PDL will be effective for dates of service (DOS) on and after October 1, 2010, unless otherwise noted. Changes in this Update do not impact members enrolled in the Benchmark Plan, the Core Plan, or the Basic Plan unless otherwise noted.
