ABC for Health & HealthWatch Wisconsin Present a Medical Debt Symposium in Appleton

Madison, WI – A "<u>Medicaid Threats & Medical Debt Symposium</u>" will convene in Appleton on Thursday, May 15, 2025. The event, running from 8:30am-noon at the Appleton Public Library, will spotlight research, policy, and direct client work of nonprofit, public interest law firm ABC for Health, and its education, policy, and outreach subsidiary HealthWatch Wisconsin.

Symposium Highlights:

- ABC for Health will review potential threats to Medicaid & BadgerCare Plus, health coverage
 programs relied on by almost 1 in every 5 people in Wisconsin. Recent executive orders, budget
 frameworks, and proposed rules could reduce access to care, increased medical debt,
 uncompensated care, and worsened health.
- ABC for Health calls medical debt a public health crisis in the Tri-County region (Calumet,
 Outagamie, & Winnebago Counties), as well as across Wisconsin and the nation. Bobby
 Peterson, Public Interest Attorney and Executive Director of ABC for Health will share details on
 the medical debt burden on Tri-County residents, looking at uncompensated care and local
 hospital financial assistance policies and practices. Nationally, hospitals dedicated on average
 about 2.3% of revenues to charity care, while Tri-County hospitals struggle to even reach 1%.
 Speakers will share findings they are compiling into a new report on the region, to be released
 later this May.
- The 2025 Community Health Needs Assessment in Tri-County will help frame our efforts to
 promote and improve access to health care coverage and services. To that end, invited guests
 will share an update on the Tri-County Community Health Improvement Coalition's work to take
 stock of the needs of the community.
- ABC for Health will share pre-recorded patient stories of Wisconsin families burdened by medical debt collections, wrongful denials, and credit reporting of debt, assisted through legal help.
